## If you decide you want to keep the vehicle(s), you must:

- Store vehicle(s) in a fully enclosed and permitted structure; or
- The vehicle(s) must be fixed and made operable.

### **Please Note:**

- Vehicle removals are reviewed on a case by case basis; not all cases are eligible. Based on Code Enforcement discretion.
- Legally mandated process can take approximately 45 - 90 days from start to completion.
- Boats, watercraft, and mobile homes do <u>not</u> qualify.
