JUNK YOUR CLUNKER PROGRAM

Contact your local Code Enforcement Office, complete the attached form and mail it to the corresponding address.

Program Benefits:

- Absolutely **FREE** of charge!
- Cleaner and safer yard for you and your family
- Hassle-free process
- Friendly staff available to answer all of your questions

If you decide you want to keep the vehicle(s), you must:

- Store vehicle(s) in a fully enclosed and permitted structure; or
- The vehicle(s) must be fixed and made operable.

Please Note:

- Vehicle removals are reviewed on a case by case basis; not all cases are eligible. Based on Code Enforcement discretion.
- Legally mandated process can take approximately 45 - 90 days from start to completion.
- Boats, watercraft, and mobile homes do not qualify.
