The County of Riverside is no longer accepting hard copies of the approved Final or Preliminary WQMPs for permanent record keeping. To facilitate plan checking, the County request the use of bookmarks for each section (Edit PDF > More > Add Bookmark in Acrobat, or ALT+B in Bluebeam).

ACCEPTABLE FORMATS FOR "REVIEW" SUBMITTALS - ELECTRONIC

- FTP Submittal. Please note, the review will not begin until the County is notified that a submittal was uploaded. ADDITIONAL SUBMITTAL REQUIREMENTS FOR AN APPROVED FINAL WQMP

- 1. A fully executed certification page(s), with owner and preparer's signature with a PE stamp. Single file PDF on M-Disc standard is required for Final Approved WQMPs.
- 2. One hard copy of a wet-signed and notarized copy of the BMP Maintenance agreement. A blank copy can be found at https://trans.rctlma.org/forms-applications#2392643287-1490630988, under the On-Line Resources tab, and Forms & Agreements under Development Review & Plan Check Section.
 - a. The BMP Agreement shall include Exhibit A and B, typically in the form of a Legal and Plat, or other reasonable form showing the applicable areas of the project.
 - b. In lieu of a Legal & Plat, a Map Book & Page Number can be referenced allowing access to the entire parcel, if references to Exhibit A and B are struck out.
 - c. Ensure that the name matches throughout the agreement and acknowledgement, using the latest California Acknowledgement page, no Jurats are accepted, the date of the agreement is the date of the notary, and all text does not exceed the margins. Then the County will sign, attest & record.
