GRADING PLAN CHECK SUBMITTAL REQUIREMENTS

SINGLE FAMILY GRADING

- Application to construct
- 3 copies of the grading plan wet signed and stamped by a registered Civil Engineer

"AS BUILT" SINGLE FAMILY GRADING (CONSTRUCTED WITHOUT PERMIT)

- Application to construct
- 3 copies of the grading plan wet signed and stamped by a Registered Civil Engineer
- 2 copies of the site Soils Investigation Report with appropriate remedial recommendations wet signed and stamped by a Geotechnical Engineer or Civil Engineer, and a report from an Engineering Geologist or Geologist if there are geologic issues in the solid investigation report
- 1 copy of the Rough Grade Certification wet signed and stamped by a Registered Civil Engineer

SINGLE FAMILY GRADING WITH 5000 CUBIC YARDS OR MORE

- Application to construct
- 3 copies of the grading plan wet signed and stamped by a registered Civil Engineer
- 2 copies of the Site Preliminary Soils Report with appropriate remedial recommendations wet signed and stamped by a Geotechnical Engineer or Civil Engineer, and a report from an Engineering Geologist or Geologist if there are geologic issues in the soils investigation report

COMMERCIAL GRADING PROJECTS

- 2 copies of the Site Preliminary Soils Report with appropriate remedial recommendations wet signed and stamped by a Geotechnical Engineer or Civil Engineer, and a report from an Engineering Geologist or Geologist if there are geologic issues in the soils investigation report
- Environmental Constraint Sheet (if applicable)
- If planning case has not been approved, an application for concurrent processing must be submitted plan check submittal
