HOW TO GET A SIDEWALK VENDING PERMIT

REQUIREMENTS AND RESTRICTIONS

If your sidewalk vending business includes the following types of **PACKAGED FOODS THAT DO NOT SPOIL**:

- Riverside County Ordinance 853 requires sidewalk vendors to have a valid Sidewalk Vending Permit with the County of Riverside Transportation Department.
- To apply for a Sidewalk Vending Permit, provide the following:
 - Completed application and \$79 permit fee,
 - CA Driver's License or ID card, individual taxpayer ID number, or Social Security Card (this information is not a public record and will remain confidential),
 - Riverside County Business Registration Certificate,
 - Valid Mobile Food Facility Permit from Riverside County Environmental Health, if selling unpackaged or perishable food.

- Keep 4 feet of space for pedestrians to walk.
- Can not sell within 500 feet of elementary, middle, or high schools.



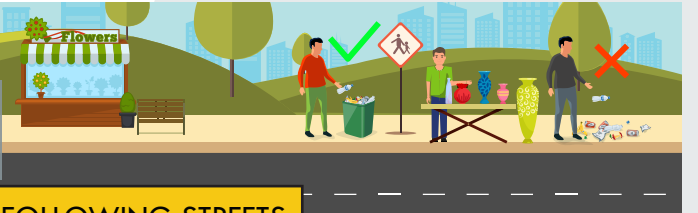
PENALTIES AND FINES

- Vendors who have a Sidewalk Vending Permit but violate the requirements or restrictions can be fined between \$100 and \$500.
- Vendors who don't have a Sidewalk Vending Permit may be fined between \$250 and \$1,000 per day.
- Vendor's equipment and items may be taken and/or destroyed if they violate certain provisions of the Ordinance 853.

A health permit is **NOT** required because these types of packaged food are not as perishable and less likely to make someone sick.

HELP KEEP OUR COMMUNITIES CLEAN

- Throw away all trash properly and do not leave on streets or sidewalks.
- Sidewalk vendors must have at least 1 trash can for customers.



All other types of sidewalk vending businesses with **UNPACKAGED OR PERISHABLE FOODS** such as:

SIDEWALK VENDING IS **NOT ALLOWED** ON THE FOLLOWING STREETS

- Cajalco Rd (Between Harvill Ave & Temescal Canyon Rd)
- El Sobrante Rd (Between Cajalco Rd & La Sierra Ave)
- Gilman Springs Rd (Between SH-60 & State St)
- Ramona Exwy (Between Rider St & Warren Rd)
- Ramona Exwy (Between Hemet St & SH-74)
- Van Buren Blvd (Between Mocking Bird Canyon Rd & Wood Rd)
- Van Buren Blvd (Between Barton Rd & I-215)
- Grand Ave (Between Marie Dr & Corydon Rd)
- Old Elsinore Rd (Between Clark St & San Jacinto Ave)
- Sage Rd (Between Cactus Valley Rd & SH-79)
- Rancho California Rd (Between Borel Rd & Butterfield Stage Rd)

- Stetson Ave (Between San Jacinto St & Stanford St)
- HWY 74 (Between City of Perris to City of Lake Elsinore)
- Reche Canyon Rd (Between Reche Vista Dr & San Bernardino County)
- San Timoteo Canyon Rd (Between Beaumont & Live Oak Canyon Rd)
- Washington St (Between Varner Rd & 42nd Ave)
- Harrison St (Between 54th Ave & 81st Ave)
- Thousand Palms Canyon Rd (Between Ramon Rd & Dillon Rd)
- Dillon Rd (Between Palm Dr & Ave 44)
- Palm Dr (Between Varner Rd & Dillon Rd)
- Grapefruit Blvd (Between 66th Ave & Airport Blvd)



A health permit **IS REQUIRED** because these types of food can spoil easily and need special handling or they could make someone very sick.
