Dear Mr. Hickman:

Please consider this as the County of Riverside's notice to your firm that it accepts your proposal received December 17, 2014 for the referenced project, and that the County of Riverside intends to award the construction contract to your firm.

Your company's Bid for the referenced project required corrections in accordance with the Instructions to Bidders section 15, "Like Bid Items" (Page A8). Unit bid prices for bid items 16, 27, and 32 were corrected. Due to these corrections, the subtotal of "Base Bid Schedule A", as written on your submitted Bid was changed from \$219,152.50 to \$218,752.50, and subtotal of "Base Bid Schedule B" was changed from \$524,879 to \$522,269.

As a result of all these changes, the project total has been revised from \$744,031.50, as written on your submitted Bid, to \$741,021.50. These corrections are reflected in the Contract. A copy of your submitted Bid is also attached for your reference.

The Contract includes Base Bid Schedules A and B; therefore, the total contract amount is \$741,021.50.

Attached for execution, by your company, are four sets of the construction contracts, Performance Bond form, and Payment Bond form.

In accordance with Section 20 "Award of Contract" of the bid documents, you are directed to return to this office, within 10 working days of the date of this letter, four (4) sets of executed original construction contracts, two (2) original Performance Bonds, two (2) original Payment Bonds, and one (1) complete insurance certificate package that conforms to the terms of the bid documents.

Insurance documentation shall include additional ensured endorsements for General Liability policies, Automobile Liability policies, and Excess Liability policies. Additionally, a Waiver of Subrogation shall be furnished for the Worker's compensation policy. Insurance carrier or their authorized broker **must sign** all additional ensured endorsements. Attached to this letter is a Brief List of Contract Insurance Requirements.

In addition to the requirements of General Conditions Section 4, "Insurance and Hold Harmless" the Contractor's Certificate of Insurance and additional insured endorsements shall name the following listed entities as additional insured under the Contractor's general liability, excess liability, and auto liability insurance policies, and each listed entity shall be named on the Waiver of Subrogation for the Contractor's Workers Compensation policy:

- 1. "The County of Riverside, its elected and appointed officials, employees, agents, and representatives".
- 2. "State of California, Department of Transportation, its elected and appointed officials, employees, agents, and representatives".

Each of the above listed entity(s) shall also be held harmless, in accordance with the requirements of Section 4, "Insurance and Hold Harmless" of the contract documents.

Failure to execute the documents and submit all of the above listed documents to the Transportation Department within the specified time may cause the County of Riverside to consider your firm as not being in compliance with the bid documents, resulting in rescission of the Notice of Acceptance and Intent to Award, and your bid bond being forfeited on that basis.

Following full execution and award of the contract by the County of Riverside Board of Supervisors, one original set of the Contract and bonds will be returned to you for your file.
